The sale will be held on November 13<sup>th</sup>, 2010 at the Redwater Horse Auction, Redwater, Alberta. 2. A non-refundable <b>catalog fee</b> may be withheld from proceeds on registered horses only. Maximum sale cost of 12% (catalog fee &amp; commission combined) of the last bid in the ring will sale be withheld sold or not. 3. Each nomination must be accompanied by a completed, consignment form, catalog fee, copy of Registration papers &amp; picture. Registration paper along with a signed transfer must be submitted on sale day. Registration papers must be up-dated to consignors ownership. Multiple transfers will be charged to consignor. Sales management will not be responsible for forgotten Registration papers and or transfers 4. Sale order and session will be as Sale Management desired, this is done by computer draw. 5. Sale Management reserves the right to reject at sale time any horse that in the sole judgment of management is not up to quality of the sale due to poor condition, sickness, injury or drugging. The nomination fee in such case shall not be refunded. All horses entered shall be subject to test by a licensed veterinarian for medication and drugs. Further, a buyer, at his expense, may cause a veterinarian's examination prior to sale, including pregnancy or fertility examination. 6. It is anticipated by Sale Management that once a horse is accepted for sale that the said horse will be offered for sale on sale day. In the event consignor should elect to consummate a sale subsequent to consignment but prior to sale date, Sale Management must be notified immediately Consignors will forfeit, the catalog fee. 7. If a horse is withdrawn from the sale due to sickness or injury, a letter from the veterinarian used must be furnished to the sale management and the withdrawal fee shall be waived. In this event a substitute horse may be offered for replacement a.s.a.p 8. Each Owner covenants and warrants that the title of each entry is free of any and all liens and encumbrances and will warrant the title to the same.</p>	<p>9. All photos submitted with consignments for publication are at the risk and liability of the consignor. Sale Company shall not be liable for any copyright infringements.</p> <p>10. Any blemish, scar, swelling, cut or other irregularity of any kind must be furnished to Sale Management and the right to announce such findings at the time of sale is hereby granted. Violation of this clause or failure to announce may give the prospective buyer the right to return any horse to the consignor and the consignor must still pay the commission fee. If your horse is turned down for any of the above reasons the horse still belongs to you. Remember, if Sale Company does not receive payment (stop payment, turn down, etc.), we cannot issue payment to you. It will also be your responsibility to make any arrangements with the prospective buyer on location and the pick up of any horse(s) should that occur.</p> <p>11. Sale Management does not act as an agent for or represent either the buyer or seller but merely provides an environment for binding together buyer and seller for the purpose of sale transactions.</p> <p>12.
